I accept my position with the understanding I may not be funded for all or any of my expenses while performing my volunteer duties.
- 6. I agree to attend the mandatory State Leadership Planning Retreat, August 20-22nd 2024 in Paso Robles County with the State Leadership Team, District Vice Presidents and other invited guests. I also agree to attend the California Network (Training) Roadshow September 9-13th 2024.
