# PACIFIC GAS & ELECTRIC TO ADOPT SPEIER'S PIPELINE DISCLOSURE LEGISLATION

WASHINGTON DC (March 2)-On the final day of a rare public hearing by the National Transportation Safety Board (NTSB) investigating the deadly pipeline explosion in San Bruno, Congresswoman Jackie Speier announced that Pacific Gas & Electric (PG&E) would adopt the major safety components of her pipeline legislation, H.R. 22 -- the "Pipeline Safety and Community Empowerment Act of 2011." The commitment was given by PG&E president Chris Johns during a meeting the two had on that day. (Source: <a href="http://speier.house.gov/">http://speier.house.gov/</a>)

Most important for California real estate professionals, PG&E committed to sending a separate "safety letter" to all of its customers in the state who reside within 2,000 feet of one of its pipelines.

The company operates in 49 of California's 58 counties, including half of the cities in the state. Its property-specific pipeline disclosure sets a standard that will challenge other utility providers to follow suit.

PG&E's action voluntarily complies with the property disclosure element proposed in H.R. 22 – a mandatory "Notice to Property Owners and Residents" -- which all gas utility companies would be forced to follow if the bill becomes law.

"These are major victories for pipeline safety," Speier added. "We learned this week that virtually no one—including the city's own fire chief—knew a pipeline was running through San Bruno. People have a right to know. These letters will go a long way toward increasing awareness about the existence of pipelines and empowering PG&E customers with critical safety information. Furthermore, PG&E's commitment to meet with all first responders will ensure no one responsible for public safety is left in the dark."

"While PG&E compromised on safety in the past, these new commitments will put it [PG&E] in position to become the industry gold standard for customer safety," Speier concluded.

#### POTENTIAL LIABILITY FOR AGENTS AND HOME SELLERS

Once disclosed to a current property owner, PG&E's pipeline proximity information would become "actual knowledge" which, under California law, the owner must disclose to prospective buyers upon resale of the property.

As yet, only PG&E customers residing near PG&E pipelines will receive the notice. Customers of other utility providers can access generalized pipeline maps on the public website of the U.S. Department of Transportation's National Pipeline Mapping System (NPMS).

To minimize the potential liability from non-disclosure of pipeline information, or faulty disclosure from a misinterpreted pipeline map, California real estate agents and brokers increasingly recommend that home sellers provide the buyer with a third-party hazard disclosure report that includes a pipeline proximity disclosure. Under the state's "safe harbor" provision of Civil Code 1102, the seller and agent are shielded from liability for disclosures contained in the third-party report.

# THIRD-PARTY DISCLOSURE REPORTS

Look closely at the seller's third-party natural hazard disclosure (NHD) report. Not all NHD providers include a pipeline disclosure in their products. And be sure to understand *which* pipelines are being disclosed. A report that covers gas transmission pipelines will not disclose hazardous liquid pipelines, which transport flammable liquid petroleum products such as gasoline and jet fuel. In 2004, five people were killed when a backhoe cut a gasoline pipeline buried alongside a Walnut Creek neighborhood.

FANHD and JCP-LGS have amassed a GIS database (digital map) of transmission pipelines throughout California that are used to transport natural gas, crude petroleum, and refined petroleum liquids such as gasoline, jet fuel, and ethanol. All major gas utility providers and oil companies, and numerous smaller pipeline owners and operators, are represented in the database -- among them PG&E, Southern California Gas, San Diego Gas & Electric, Sacramento Municipal Utilities District, Tuscarora Gas, Chevron, ConocoPhillips, Exxon Mobil, Kinder-Morgan/SFPP, BP West
